



CLIENT SUCCESSES

IP

Levi Strauss & Co. Successfully represented **Levi Strauss & Co.** in a multi-million-dollar licensing and patent infringement dispute relating to the treatment of denim fabric with ozone.

BUSINESS

dwell

Represented long-time client **Dwell**, a premium home design magazine turned-digital media brand, in its acquisition by Recurrent Ventures. The venture equity-backed digital media company owns more than 25 brands, including Bob Vila, Business of Home, Domino, Popular Science, Saveur, and many others.

LITIGATION



Representing **Delta Dental of California (DDC)**, one of the largest dental insurers in the U.S., in a complex, purportedly multi-million-dollar dispute involving claims that allege DDC made defamatory statements regarding one of the leaders in the multi-billion-dollar invisible aligner industry. DDC denies the allegations and is vigorously defending this lawsuit.

APPELLATE



Won a 9th Circuit appeal, in a published decision, for **a pro bono client** who was denied asylum by an immigration judge and the Board of Immigration Appeals. The decision sets a favorable precedent for asylum seekers regarding the materiality of certain inaccurate information provided in an asylum application.

GOVERNMENT



Represented **Santa Clara Valley Transportation Authority (VTA)** in executing a multi-billion-dollar progressive design-build agreement with the joint venture of Kiewit/Shea/Traylor for the design and construction of VTA's Tunnel/Trackwork Project, the largest of four related contracts that will result in the delivery of Phase II of BART to Silicon Valley Project and the extension of BART from Milpitas, under downtown San Jose, to Santa Clara.

CONSTRUCTION



Represented the **Regents of the University of California** in connection with a New Hospital at Parnassus Heights (NHPH) in San Francisco. The \$4.3 billion NHPH project is the largest public Integrated Project Delivery (IPD) project in the U.S. We developed the IPD agreement, negotiated the Community Workforce Agreement and are continuing to provide assistance during implementation of the project.

GOVERNMENT



Obtained a significant win for long-time clients the **Golden Gate Bridge, Highway & Transportation District (District) and the Bay Area Toll Authority (BATA)** in a complex putative class action alleging that the District and BATA improperly disclose personally identifiable information (PII) in violation of state privacy laws. After more than six months of briefing, the Court denied Plaintiffs' motion for class certification in its entirety on the grounds that the Plaintiffs' claims lacked merit as a matter of law.
